BASE RATE SCHEDULE

Individual Companion Care	\$26/hr – anything less than 168 hours per week \$25/hr – 168 hours per week	3 hour minimum per visit For 2 hours, this is \$45/hour
Individual Home Health Aide / Certified Nursing Assistant	\$30/hr – anything less than 168 hours per week \$28/hr – 168 hours per week	3 hour minimum per visit For 2 hours, this is \$45/hour
Couple Companion Care <i>*if one member of the couple requires higher care, then the rate is at the higher care rate.</i>	\$32/hr – anything less than 168 hours per week \$31/hr – 168 hours per week	3 hour minimum per visit For 2 hours, this is \$51/hour
Couple Home Health Aide / Personal Care	\$36/hr – anything less than 168 hours per week \$34/hr – 168 hours per week	3 hour minimum per visit For 2 hours, this is \$51/hour
Precautions Any client that is required to be on Medical Precautions as designated by a physician (may include Contact, Airborne, Droplet or a mix thereof)	\$6/hr additional to base rate while on precautions plus additional \$100 per week This allows for all supplies/Personal Protective Equipment and for necessary staff assignment.	Added to scheduled visits.
Nursing Services	Registered Nurse: \$129 for the first hour of any visit, then \$90 for every hour thereafter. On Weekends or After Hours/Short Notice (<48 hour notice): \$145 per hour, minimum of \$145 per visit. Licensed Practical Nurse: \$75 for the first hour of any visit, then \$50 for every hour thereafter. On Weekends or After Hours/Short Notice (<48 hour notice): \$129 per hour, minimum of \$129 per visit.	1 hour minimum per visit Nurse's level is assigned based on regulation requirements and availability.
Respite Services Client remains on our service roster without regular visits	\$125/month for an individual, OR \$200/month for a couple	3 hour minimum per visit when scheduled

ADDITIONAL RATES

All rates below pertain to all Silver Linings Home Healthcare clients.

Initial Payment Due	Two weeks of anticipated cost of care, plus \$149 for comprehensive assessment. **Initial Payment minus \$149 will be applied to your final bill.
Mileage Charge for Travel in Caregiver Car	\$0.61 per mile
Case Management Fee	\$49 per hour – billable in 15 minute increments.
High-Acuity Case Any client designated a palliative care or hospice case, or at Stage 4 or later on the Dementia scale, or >20 points of the level of need calculator	Additional \$2/hour. This acuity-based hourly add-on allows us to provide the additional case management and enhanced team communication/education required.
